## 5. Recognition of Visitors/Public Comment

Residents spoke in opposition to the sale of any White Pines property:

- Mike Jaffee White Pines was purchased in 1967 as a result of a referendum. Selling the property without a referendum is wrong; he suggests a binding referendum be held.
- Gary Gardner Spoke in opposition to industrial uses and the use of the White Pines property for a sports facility. He stated the Board should not sell the property for a one time windfall for the little benefit the sale will bring.
- Valeria Special Cited a May 21, 2018 article in a club and resort magazine concerning the potential sale of the golf course, where Commissioner Johnson spoke in opposition to the sale of the property, and the District's attorney suggested the possibility of a referendum prior to consideration of the sale.

- Chuck Rizzo The Board has spent \$400,000 in due diligence to sell land, but is not taking in account staff and attorneys fees to support the sale of the land, which increases the amount of money spent without having studies to determine the negative impact of the sale on the community, impact on property values, impact on environment and the possible increase in traffic, police need and crime.
- Bill Hibner Opposes the sale of the Course which is making a profit, and does not want to see the land sold for industrial development. He suggests a referendum on the sale.
- John Wassinger Encouraged the Board to have a binding referendum to sell the White Pines Property, which will let the public decide what should be done.

In discussion, Mr. Vallez stated if the Board was going down the path of an advisory referendum on this issue, it should also consider other topics as well, including whether the public would support an indoor aquatic facility, and a binding referendum on whether it should issue \$20 million in bonds for capital projects.

President Johnson suggested going for the proposed bond issue, to take care of antiquated buildings, including the White Pines Club house which has major roof issues. A binding referendum on the sale of \$20 million in bonds would add to funds the Park District currently has or will have to repair the club house, the pool, and splash pad, all of which are antiquated and in need of repair.

He noted that a bond issue would increase taxes and asked whether Mr. Vallez could comment on this. He stated he would need to speak with bond counsel and Speer Financial to address those questions.

The motion was expanded to direct staff to prepare documents needed for the three topics proposed.
